

**Graybill Conference VII
June 11-13, 2008
Biopharmaceutical Statistics**

This conference will provide an opportunity for statisticians from pharmaceutical companies, industry, universities, and government agencies, and graduate students preparing to enter this field, to meet and share the current state of statistical methods needed in the biopharmaceutical industry.

The conference will take place on June 12th and 13th at the Hilton - Fort Collins in Fort Collins, Colorado. A full day short course on "Hot Topics in Clinical Trials" and a half-day short course on "Statistical Graphics for Clinical Data Analysis" will be offered on June 11, 2008, the day preceding the conference.

The conference will consist of four keynote talks and several invited talks on topics relevant to the pharmaceutical industry by several prominent researchers.

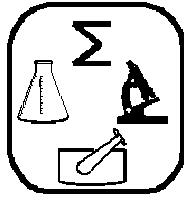
Poster Presentations
